The **Local Public Sector Alliance (LPSA)** is a global network of citizens, policy practitioners, government officials, scholars, and development professionals that seeks to elevate the debate on public sector decentralization and localization in order to promote inclusive, equitable societies and sustainable global development.

LPSA maintains its main website — **Decentralization.Net**—as a global convening place for policy makers and researchers interested in decentralization and localization. *Decentralization.Net* is free and open to both members as well as non-members. In addition, the Local Public Sector Alliance has established an online member portal—**localpublicsector.org**— that allows its members to connect, engage, and share with each other.

Membership of the Local Public Sector Alliance is free. There are several advantages to registering as a LPSA member, including—but not limited to—receiving our newsletter; registering for working groups; being listed in our online member directory (if you wish) and access to online discussion forums on issues related to decentralization and localization. In addition, membership gives you access to LPSA Online Courses.

Registration

Links to sign up (or sign in) as a member of the Local Public Sector Alliance can be found on the home page of our member portal. The registration page can be found on **Decentralization.net** under the main menu (membership / register) or at **localpublicsector.org/register**.

One of the benefits of registering as a member of the Local Public Sector Alliance is that it allows us to send you LPSA's bi-monthly newsletter.

You have two main membership options. If you only want to receive LPSA's newsletter—but do not want to be included in our public (online) member directory—select the Private Membership option. Alternatively, choosing the **Global Membership** option will provide you with full access to all membership benefits.

You will be able to switch to the Private Membership and Global Membership options at any time.



Basic member account settings

Once your email has been validated, you will be able to complete your account profile and access other account information through the member menu by clicking your username or the icon in the top righthand corner of the portal.

The dropdown menu will allow you to update your Profile Photo and Cover Photo, along with the ability to view or edit other account details and profile details.



Working Group Selection

LPSA membership enables you to select what regional or thematic working groups you would like to receive updates from, and allows you to communicate with LPSA members that share your interests.

Joining working groups. A list of LPSA's regional or thematic working groups is visible from the main menu. Once you are registered and logged in, you will have the option to join a working group by selecting the "Join Group" button.

Note that if you opt to join a working group, your profile information will become visible to other logged-in LPSA Members through the Group page, even when you are a Private Member.

Profile Details

Registering as a Global Member of the Local Public Sector Alliance allows you to create a member profile and publicly share your experience and expertise as part of LPSA's online member directory.

In turn, LPSA's Member Directory allows colleagues in the community of practice to contact you without ever disclosing your email address—thus enabling others to learn from your experiences and expertise in decentralization and local governance.

Member Details and Profile Details. In addition to the Member Details (the information provided during registration), your LPSA Member Profile allows you to provide further details about yourself, including Organization, Position, Member Bio, and Experience and Expertise. The Profile Details can be edited by clicking on "Profile" and "Edit" in the member menu, and then selecting the "Profile Details" tab.

The City and Country (location) field in the Profile Details is used for locating your pin on the membership map. For privacy reasons, we strongly encourage you to only provide the city and country, rather than providing your full street address.

Member Directory and Map


LPSA's Member Directory allows colleagues in the community of practice to contact you—without ever disclosing your email address—thus enabling others to learn from your experiences and expertise in decentralization and local governance.

The LPSA member directory—as well as the member directory map—is publicly available through the portal's main menu.

The online directory and member map show all LPSA Global Members. Private Members are not included in the public member directory or the map. The member directory is publicly searchable by name or based on words included in each member's profile.

Whereas non-members can see and search the online directory, they cannot access individual Member Profiles.

Only logged-in LPSA Members will be able to see your full LPSA Profile, unless your profile type is set to Private.



Messages and Notifications

When an LPSA member sends you a message through the LPSA Member Portal, or when someone interacts with your content on the portal (e.g., replies on a Forum), you will receive a notification in the Member Portal. In addition, you will also receive an email to alert you to the message. These notification emails will be sent by **portal@localpublicsector.org**. You may want to ensure that your email spam folder

You can opt out of receiving notifications emails (by type of notification) in the Notifications Settings section of the Member Account.

LPSA Newsletter Opt Out / Opt In

Every LPSA Member will receive LPSA's bi-monthly electronic newsletter. However, the LPSA Member Portal allows LPSA Members to opt out of receiving LPSA's Newsletter (or opt back in, as preferred). Separate from other notification settings, this setting is available under the member's Profile settings.

Profile Types

In addition to Global Members and Private Members, the LPSA Member Portal can assign several other Profile Types, identifying LPSA's Secretariat, LPSA Working Group Co-Chairs, and other LPSA officials. In addition, a number of special membership designations are available. These designations are made by the LPSA Secretariat.

Forums

LPSA Members can access member-only Discussion Forums. The content of these forums are not visible to non-members.

Since forums are generally linked to global regions or working group thematic areas, registering for a working group will give you automatic access to the corresponding forum.

LPSA Online Courses

The LPSA Member Portal allows members of the Local Public Sector Alliance access to LPSA's online courses free of charge. Upon course completion, a printable Course Certificate is issued.

LPSA Membership Certificate

The LPSA Member Portal enables its members to print a Local Public Sector Alliance Membership Certificate. In order to access the Membership Certificate, each member is required to complete the short "LPSA Member Certification" course.

Terms of Service

The Local Public Sector Alliance member portal (localpublicsector.org) allows its members to connect, engage, and share information with each other. The Terms of Service for LPSA'S Member Portal are available in full at https://localpublicsector.org/terms-of-service/.
